Control4® OS 2.0 will be sold by the Control4® Dealer network. Software licenses will be required for prior version systems that will be upgraded to OS 2.0.

## **System Requirements:**

OS 2.0 is a complete system software release. All Control4® devices have software or firmware. The OS 2.0 update process will require that all devices in the entire Control4® system be updated. Please see the *Control4 Operating System (OS) Release Version 2.0 Release Notes* for specific information before scheduling customer installations. A *Read This First* document is also available also for a snapshot of the major changes in this release.

- Locale ability to select the language used by the Flash Navigator interface. Control4® OS 2.0 ships with support for six languages: French, Spanish, Chinese, Russian, Portuguese, and English. New languages can be added easily to the OS using our Language Development Kit. Support for new languages does not require a software update, so check your system often to see if new languages have been added.

# How do I purchase and apply OS 2.0 Software licenses?

The OS 2.0 software licenses can be electronically purchased using a credit card by authorized Dealer account holders on my.control4.com. They can be purchased also using the standard purchase order process through Control4 and Control4® Distributors.

## Do all systems need a software license to upgrade to OS 2.0?

Yes. All existing systems need an OS 2.0 software license to upgrade. Exceptions:



- Control4® systems registered on my.control4.com using a Dealer account do not need an OS 2.0 software license. These systems will upgrade to OS 2.0 without a license.
- Control4® Controllers (HC-200, HC-300, HC-500, or HC-1000) that were purchased during the free upgrade window and are functioning as the Primary Controller will upgrade to OS 2.0 without requiring a license.

## What is the free upgrade window and how does it work?

On December 23, 2009, in conjunction with the announcement of new lighting products based on ZigBee® Pro, Control4 announced that Controllers purchased on or after that date would be eligible for a free upgrade to OS 2.0. No paperwork or manual procedures are required to access the free upgrade, however, the Controller must be the Primary Controller (running Director) when the upgrade is performed in order to receive the free upgrade.

# Is there a reduced price for the OS 2.0 software upgrade for Dealer and Installer homes not registered on the Dealer account?

Yes. Control4 is providing the OS 2.0 Software License through the Dealer employee accommodation program. The employee accommodation price is \$39.95 and will be available for 60 days.

#### Do new systems purchased by customers need an OS 2.0 Software License?

No. All new systems have the ability and license to run OS 2.0. The OS 2.0 Software License is only required to upgrade existing systems to OS 2.0.
